

## Evangel Christian School K4 Tuition and Fees for 2015-2016

K4 students must be 4 years old by September 30.

Half Day Hours are 8:20 AM to 11:20 AM, Monday through Friday

Full Day Hours are 8:20 AM to 3 PM, Monday through Friday

### **Registration Fees:**

**Registration Fees must be paid in full to hold a position for your child and are non-refundable, unless a family moves more than 25 miles from the school **prior** to the first day of school.** The registration fee covers the costs involved in registration and enrollment. If the school does not accept a student and the registration has been paid, the fee will be refunded.

**Material and Activity Fee (MA Fee):** MA Fee: **\$325.00**

**The MA Fee is due on July 1st of each year** and **is non-refundable after September 1st.** This fee covers the curriculum, classroom supplies, and music and art supplies. This fee also pays for student ODACS fees, and an "Eagle Pass" that will admit all family members to all regular season home athletic contests. (Post season play is not included.) *After July 1st, a student may lose their position in the class if this fee is not paid.* Students enrolling after July 1st, must pay the registration and MA fee when they submit their admission or reenrollment paperwork.

### **Tuition and FACTS Tuition Management:**

**FACTS** is an online tuition payment system that is used for withdrawing tuition directly from your bank account on the 5th of each month. All families must enroll in the FACTS program for tuition payments and the Evangel Business Office can assist in that enrollment process. Tuition Fees cover the regular operating expenses of the school. Tuition does not cover incidental expenses such as some field trips, individual expenses for fine arts competition and science fair project expenses.

FACTS offers a 12 month (July—June) or 10 month withdrawal plan (August-May).

**Families that enroll in the 12 month plan by June 20th may roll their MA fees into the payment plan without penalty.**

K4 Half Day Program (8:20-11:20)                      \$3,300 per school year

K4 Full Day Program (8:20-3:00)                      \$5,165 per school year

**There are not multiple child discounts for K4 tuition due to limited space and the costs of a program of this nature.**

### **Discounts:**

**Early Payment: a 3% discount will be given for yearly tuition paid in full before August 1st.**

**All fees must be paid in full to qualify for the discount.**

### **School Student Referral Program (PSST):**

Any parent referring a new student to the school will receive a tuition discount of 10% of the new students tuition fee. Forms and information on how the PSST program works are available in the school office. You must submit a PSST form **prior to their first interview** to qualify. Referrals are paid out February 1st.. Referred families account must be in good standing at the time of referral.

## Extended Daycare (EDC)

### Full Time Extended Daycare- (Formally called Monthly EDC)

Families requiring Extended care should enroll during Registration. Families should decide if they want to enroll in a Full time plan or an Hourly plan. In general, if a student will be using more than 5 hours per week in EDC, they should enroll in a Full time plan. The yearly cost of the program is divided up into 10 or 12 payments depending on which FACTS plan is chosen. Families may enroll or withdraw from Full Time EDC at anytime during the year and costs will be prorated according to either the start date or end date, whichever is appropriate, and the necessary adjustments will then be made in FACTS. **Please try to limit enrollment changes to two per school year.** Please call the Business office to make any changes to EDC status.

### Hourly Extended Daycare—

Students may use hourly EDC as needed, but they are still required to enroll at Registration. They will only be charged as care is used. Hourly EDC is invoiced mid-month then added to FACTS for the next payment.

**All children not enrolled in Extended Care or Full-Day programs, who are here beyond their scheduled times will be charged for hourly EDC.** Children not picked up by 6:00 PM will be charged \$10.25 for each 15 minutes or part thereof. That rate will increase to \$15.50 after 7 PM.

**FACTS Return Fee :** \$35

## Refunds

There are no refunds for any fees paid unless otherwise noted.

## Withdrawals:

Students that withdraw are required to give two weeks notice. If not, an additional two weeks tuition will be charged to that family's account. Tuition for that student is calculated at a daily rate multiplied by the number of days attended. Any tuition that was paid in advance, will be refunded within a month of withdrawal.
